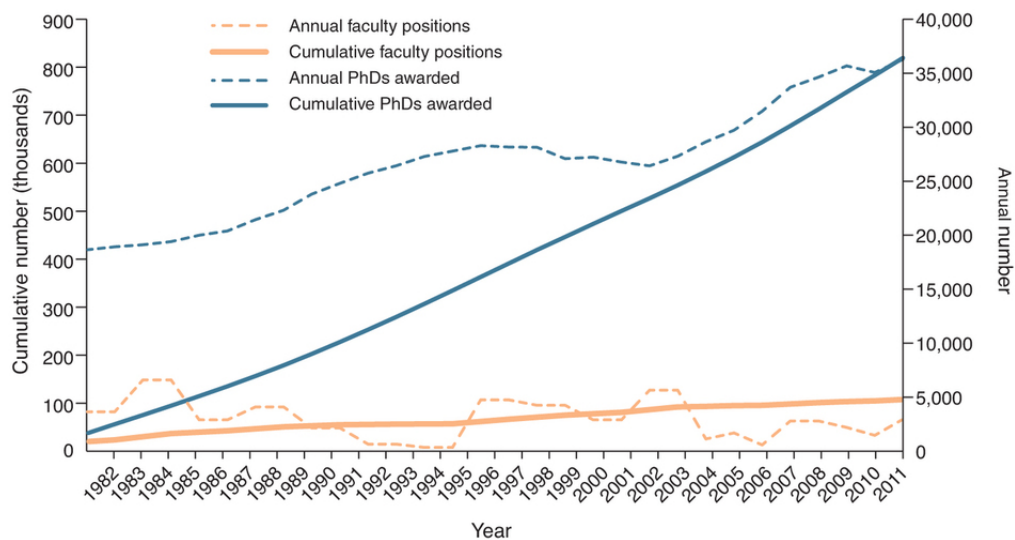


Figure 1: NEW FACULTY POSITIONS VERSUS NEW PHDS

2.3.4 DEFINITION LIST

The following is a list of definitions. Not all dissertations will contain such a list, but it is acceptable. Below is an acceptable format for listing a few definitions.

Dissertation - a written essay, treatise, or thesis, especially one written by a candidate for the degree of Doctor of Philosophy (PhD)

Mathematics - the systematic treatment of magnitude, relationships between figures and forms, and relations between quantities expressed symbolically.

Statistics - the science that deals with the collection, classification, analysis, and interpretation of numerical facts or data, and that, by use of mathematical theories of probability, imposes order and regularity on aggregates of more or less disparate elements

2.4 ABBREVIATIONS

This template includes the *nomencl* package which makes creating a list of abbreviations very easy. Suppose you wanted to abbreviate South Dakota State University (SDSU) . Just add

```
\nomenclature{SDSU}{South Dakota State University}
```

after your first use of the abbreviation. Then an abbreviation page will automatically be created with the abbreviations. It page will also be alphabetical regardless of the order of abbreviations in the document.

2.5 REFERENCE OTHER LOCATIONS IN DOCUMENT

\LaTeX provides a very simple strategy for referencing others parts in the document. For example, you can easily reference Appendix A. Just include

\label{YourLabelName}
```

where you want to reference. Then just use the following to reference that location.

2.6 MATH FORMULAS
